### Query raised by M/s. Agilent Technologies India Pvt Ltd

- 1 Point No 3 vendor suggested 25 or more deck position with a stacker or equivalent.

  Suggested to Change plate reading to Plate Barcode Reading. \* (Subject to Verification).
- 2 Point No. 4 vendor suggessted aspiration of 300 micro litres 3 to 4 times for large volume.
- 3. Point No. 6 vendor suggested 1 % accuracy or less than 5% CV.
- 4. Point no 7 vendor said he cannot provide on deck PCR
