# **Terms & Conditions**

- The validity of the offer should not be less than 90 days. Please mention your GST Registration No. in the offer.
- 2. The Director, CCMB reserves the right to cancel the Purchase Order without any financial repercussions on either side and without seeking the consent of the supplier at any stage of the purchase process.
- Payment will be made by RTGS/NEFT/Account payee cheque only, after receipt of the stores in good condition.
   Advance payment terms will not be accepted. In case of foreign suppliers, payment will be done by WT/LC/FDD.
- 4. Specifications are basic essence of the product. It must be ensured that the offers are strictly as per our specifications. At the same time it must also be kept in mind that merely copying our specifications in their quotation shall not make firms eligible for consideration. A quotation has to be supported with the printed technical leaflet/literature (wherever applicable and available like in case of scientific items, misc. IT/Office products, readymade furniture) and the specifications mentioned in the quotation must be reflected/ supported by such printed technical leaflet/literature model quoted/tendered specifications should invariably be highlighted in the leaflet/literature for easy reference. In the event of any ambiguity/confusion on account of item specification/description, the offer will be rejected without giving the quoting firm any opportunity for clarification/negotiation. In case the quotation is submitted by Authorised Agent/Dealer, the same must be accompanied by valid authorization letter from principals. Accordingly technically unsuitable offers, offers not confirming to tender schedule or offers from defaulters etc. will also be rejected.
- 5. In case of equipments/instruments Original Equipment Manufacturers, their Authorised Distributors and Indian agents of Foreign Principals, if any, should only submit their ONLINE e-bids under Single Bid System through CPP Portal https://etenders.gov.in. Bids will not be accepted in any other form.
- **6.** The Purchaser may, at its discretion waive any minor informality, non-conformity (technical or commercial), or irregularity in a bid, which does not constitute a material deviation, provided such a waiver, does not prejudice or affect the relative ranking of any Bidder.
- 7. Please ensure that quoted prices are minimum prices applicable for a premier research institution, leaving no scope for any further negotiations on prices and the price quoted is not more than the price offered to any other customer in India to whom this particular item has been sold, particularly to CSIR Labs/Institutes and other Government Organizations nor will they do so till the validity of offer or execution of the purchase order whichever is later. Copy of the latest price list for the quoted item, applicable in India, must be enclosed with your offer.
- 8. Enclose with your offer a certificate that the equipment is of latest technology and will not become obsolete soon and accessories & spare parts will be supplied as and when required. It may be confirmed that essential spare parts of this equipment are available for after sale service of the equipment. Please also specify the time period required for installation of the equipment after its receipt at CCMB is notified to you.
- 9. The bid must mention the prices of all items asked for individually and then summed up at last i.e. package deal for all items which are essential for the system as per our tender. Optional items asked for can be submitted separately in the bid.
- **10.** Pre-installation requisites (electrical/floor/space/air-conditioning etc.) if any should invariably be mentioned clearly. Installation/ Training will be the full responsibility of the supplier.
- **11.** If any short-shipment etc. is noticed, the same will be arranged immediately with all charges to this effect to be borne by supplier.
- 12. The goods should be insured against theft, loss or breakage during transit and insurance charges should not exceed 1% of the cost of material supplied, the rate of GST etc. (as applicable) should be clearly indicated. CSIR-CCMB is eligible for payment of GST @ 5 % for procurement made for R & D purpose being a public funded research Institution registered with DSIR in terms of Govt. of India Notification No. 45/2017 Central Tax on the subject, as amended from time to time. Required certificate to this effect will be provided when you confirm delivery of ordered item.
- 13. In case of supply order for the SCIENTIFIC EQUIPMENTS/ APPARATUS, the date of delivery should be strictly adhered to otherwise the Director, CCMB reserves the right not to accept delivery in part or full and claim liquidated damages of 1% per week subject to maximum of 10% of the total value of supply order.
- **14. Printed conditions of the quotation shall not be binding on us.** Quotation must be clearly written or typed without any cutting or over-writing and signed. **Unsigned quotation will be rejected**.
- **15.** All items should carry normal warranty period of at least one year from date of installation. Therefore Warranty/Guarantee period should be mentioned clearly in the offer. Please also quote tentative Annual Maintenance Charges (both AMC & CMC) as %age of value, if any, for next 5 years, after warranty/Guarantee period is over.

- **16.** If the vendor has supplied identical or similar equipment to any Govt. Institutes/universities or other CSIR labs/institutes, the details of such supplies for the preceding three years shall be given together with the prices eventually or finally paid.
- 17. Provide the list of users in India, particularly CSIR Laboratories, along with their complete address including fax, e-mail etc. Also enclose performance certificate, if available.
- **18.** Conditional tenders/discounts etc. shall not be accepted. Rates quoted *without attached conditions* (viz. Discounts having linkages to quantity, payment terms etc.) will only be considered for evaluation purpose. Thus conditional discounted rates linked to quantities and prompt/advance payment etc, will be ignored for determining *inter-se* position. The Director CCMB however reserves the right to use the discounted rate/rates considered workable and appropriate for counter offer to the successful tenderers.
- 19. The acceptance of the quotation/offer will rest with the Director, CCMB, who does not bind himself to accept the lowest quotation and reserves the right to himself to reject or partially accept any or all the quotations received, or to waive off any condition without assigning any reason.
- 20. TDS/TCS, if applicable, will be deducted as per applicable statutory norms prescribed by the Govt.
- **21.** The Purchaser requires that bidders, suppliers, contractors and consultants, if any, observe the highest standard of ethics during the procurement and execution of such contracts
- 22. Arbitration: In case of Dispute or difference arising between the Purchaser and a domestic supplier relating to matter arising out of or connected with this agreement, such disputes or difference shall be settled in accordance with the Indian Arbitration & Conciliation Act, 1996, the rules there under and any statutory modifications or re-enactments thereof shall apply to the arbitration proceedings. The dispute shall be referred to the Director General, Council of Scientific & Industrial Research (CSIR), New Delhi and if he is unable or unwilling to act, to the sole arbitration of some other person appointed by him willing to act as such Arbitrator. The award of the Arbitrator so appointed shall be final, conclusive and binding on all parties to the Contract.
- 23. Any dispute will be amenable to applicable Indian laws subject to jurisdiction at competent local court at **Hyderabad**, India only.
